## Nigeria arrests Boko Haram commander

**NIGERIA:** Nigeria's secret police said Sunday they had arrested notable Boko Haram suspects, including a key commander, linked with several suicide attacks across the country.

The Department of State Services (DSS) said in a statement that Usman Shuaibu known as Money and other frontline members of the hard-line group were picked up in Lagos, Kano, Plateau, Enugu and Gombe states between July and August.

"Of particular note was the arrest on July 8, 2015, in Gombe state of those responsible for the coordination and execution of the suicide attacks in Potiskum, Kano, Zaria and Jos," it said.

Shuaibu admitted being the leader of the team of nine sect members that was dispatched from Sambisa Forest to carry out the attacks. — AFP

Al Jazeera described the verdict as an "attack on

press freedom".

"It's a dark day for the Egyptian judiciary," Giles Trendle, the English channel's acting managing director, told reporters in Doha.

"Rather than defend liberty and the free and fair media, the Egyptian judiciary has compromised its own independence."

Al Jazeera's head of litigation, Farah Muftah, said in Doha the ruling would be appealed once the judge publishes the basis for his sentencing.

Rights advocates say their arrest was part of a crackdown on free speech waged since the army over-

threw President Mohamed Mursi, a senior Muslim Brotherhood figure, in July 2013 following mass unrest over his rule.

The three men were originally sentenced to seven to 10 years in prison on charges that included spreading lies to help a terrorist organization, a reference to the Muslim Brotherhood, which the military toppled from power two years ago.

The three defendants denied all charges, calling them absurd. Three other Egyptians, all students, also received three-year sentences for the same charges.

Beforehand, The United States

had also stated it was "deeply disappointed and concerned" over the trial, calling for the ruling to be overturned.

"We urge the government of Egypt to take all available measures to redress this verdict, which undermines the very freedom of expression necessary for stability and development," State Department spokesman John Kirby said in a statement.

Washington added its heft to growing international outrage at the ruling after the Cairo court said the trio had broadcast "false" news that harmed Egypt.

Monday, a bomb exploded near the US Embassy in Sana'a, wounding several gunmen shot and

killed a senior security official in the southern port city of Aden.

There were no immediate claims of responsibility, but al-Qaeda in the Arabian Peninsula — the deadliest branch of the global militant organization — has been attacking the Yemeni state and plotting against Western targets for years.

A powerful bomb detonated in front of a gate on the wall surrounding the embassy around midnight on Sunday but claimed no casualties, residents and officials said.

In Aden, the local director of security, Colonel Abdul Hakim Snaidi, was shot dead outside his home by gunmen in a passing car, a security official said.
